

STARCASTER™ **Drum Pack** by *Fender®*

LIMITED WARRANTY

Fender Musical Instruments Corporation ("FMIC") warrants that the Starcaster drums, drum hardware and accessories you have purchased shall be free of any defects in materials and workmanship subject to the following terms, conditions and limitations.

Drum shells are warranted for a period of three (3) years from the date of purchase or initial lease. Hoops, wrapped finishes, all hardware and accessories including: cymbals, stands, pedals, thrones and gig bags are warranted for a period of one (1) year from date of purchase or initial lease. This warranty shall run to the original purchaser or lessee when purchased or leased from an Authorized Starcaster Drum Pack Dealer.

The following items are **not** covered by this Starcaster Drum Pack warranty:

1. Repair or replacement of expendable and routine maintenance items including, but not limited to; cymbals, drum heads, pedal beaters, springs, snares, keys, sticks and straps.
2. Damage and deterioration that result from normal usage, wear and tear or aging.
3. Damage and deterioration that result from misuse, abuse, accidents, negligence, exposure to harmful changes in temperature or humidity and Acts of Nature.
4. Any damage to a drum or drum accessory product resulting from customization, modification or alteration.
5. Damage, corrosion or rusting of any plated hardware surface.
6. Normal wear and tear on any part of a drum gig bag including zippers, and handles etc.
7. Sound and tonal characteristics of drum and cymbal products. (The perception of sound and tone is subjective and as such, is not covered by this limited warranty).
8. Any drum or drum accessory product purchased from anyone other than an Authorized Starcaster Drum Pack Dealer.
9. Starcaster drum or drum accessory products that have been serviced by any person or entity not authorized by FMIC.

IMPORTANT: PLEASE RETAIN YOUR ORIGINAL SALES RECEIPT OR LEASE, AS IT IS YOUR PROOF OF PURCHASE VALIDATING YOUR LIMITED WARRANTY.

Defective products that qualify for coverage under this warranty will be repaired or replaced, (at FMICs discretion), with a like or comparable product, without charge. To receive warranty service, return the product to the Starcaster Drum Pack Dealer from whom it was purchased, with your sales receipt establishing proof and date of purchase, during the applicable warranty period. **TRANSPORTATION COSTS INCURRED FOR THE PURPOSE OF RECEIVING WARRANTY SERVICE ARE NOT INCLUDED IN THIS LIMITED WARRANTY.**

THE FOREGOING CONSTITUTES THE ONLY WARRANTY MADE BY FMIC WITH RESPECT TO THE PRODUCTS AND IS MADE EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES EXPRESS OR IMPLIED. Any implied warranties, including without limitation, any implied warranties of merchantability or fitness for any particular purpose, imposed under state law are limited to the duration of this limited warranty. Some states do not allow limitations on how long an implied warranty lasts, so the above limitations may not be applicable to you.
